

LIST OF RIGHTS AND BENEFITS FOR NEW OLIM (IMMIGRANTS)

This list is intended to provide a general picture only, and is not binding. The rights of each oleh are granted according to his or her individual situation, and in certain cases the Oleh (Immigrant) may be eligible for only some of these rights.

- ▶ One-way Flight ticket to Israel and limited overweight allowance.
- ▶ Absorption basket grant (*sal klitah*) – financial assistance during the first 7 months, intended for basic living expenses during the first year.

- ▶ *Free Ulpan* studies for 5 months (pensioners are able to receive a 10 month Ulpan).

- ▶ Residence at an absorption center for up to six months at subsidized rental rates. (Maximum age: 55).

- ▶ Available for 3 years from date of Aliyah: Customs free importation of household goods and electrical appliances – up to three containers. Customs reductions on equipment for establishing a business, valued at no more than \$36,000. Customs reduction on a new car. VAT reduction on the purchase of one new Israeli made fridge and air-conditioner.

- ▶ Symbolic rental assistance for four years, starting from the second year (for those not registered as owners of property in Israel).

- ▶ Mortgages at special terms for new *olim* – available for 10 years from date of Aliyah.

- ▶ Grant for tuition fees at recognized institutions of higher education for up to three years for 1st degree, or 2 years for 2nd degree (when applicable). Maximum starting age for first degree: 27 years. Maximum starting age for second degree: 30 years.
